Please refer to your application No. **NMC/PG/2024-25/000646** for **starting** of new PG course in **MD - Anatomy** with 11 seats at Zydus Medical College & Hospital Dahod under Shri Govind Guru University, Godhara u/s 26(1) (a)(b) and 28 (1)(2) of the NMC act,2019 for the academic year 2024-25, MARB's **Letter of Intent (LoI) dated 05.06.2024** and your reply **dated 12.06.2024** on the subject mentioned above.

With approval of Competent Authority it is to inform that **Medical Assessment & Rating Board (MARB), National Medical Commission (NMC)** has approved **starting of MD - Anatomy** course for **02 (Two) seats** per year with effect from the academic year 2024-25 at Zydus Medical College & Hospital Dahod under Shri Govind Guru University, Godhara u/s 26(1)(a), 26(1) (b) and 28 (1)(2) of the NMC act, 2019 as amended time to time.

2. This permission for **starting** of above-mentioned course and admission of student will be till such time the first batch of student admitted against the above course appears for the final examination in the subject. The college authorities may take up the matter for recognition of the qualification under section 11(2) of the IMC Act at the time of first batch admitted against the sanctioned intake for final year examination with the Central Government.

3. It is further informed that you and your institution is fully responsible to fulfil and maintain the norms including the infrastructure both physical and human resource, teaching faculty, clinical material and stipend to PG students similar to PG Students of Government colleges in the state etc. throughout the academic year, **as stipulated in Act/Rule/Regulations of NMC.**

4 . In case false/wrong declaration or fabricated document have been used for procuring permission and any misconduct is brought to the notice of National Medical Commission (NMC) or found during surprise assessment at any stage during the current academic year, your institution is liable not to be considered for recognition of the at degree. This letter of permission will be revoked for the current academic year if such exigency arises. Besides, National Medical Commission (NMC) is entitled to take all such measure against you and your college/institution as permissible under the law.

5. It is mandatory by the Government medical colleges to contribute 15% MBBS seats and 50% of Post Graduate Broad specialties (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the direction of hon'ble Supreme Court of India.

6. It is mandatory to develop a website of medical college/institution and display all the information of college, courses offered, faculty available and their experience of last 5 years, students joined and affiliating university to display the hospital service, facilities available and the equipment's in each specialty also showing OP and IP census including births and deaths as per the municipal/Government records.

7. As per Clause 6 of regulation "The opening of the new or Higher course of study or training including post graduate course or study or training and increase of admission capacity in any course of study or training (including a postgraduate course of study or training) regulations, 2000", submission of Bank Guarantee for the course **MD - Anatomy is exempted.**
